Cams4us.com is an international site, therefore we expect you are known to the English language. We will not supply you with any agreements in other languages than English.

As a condition of you using the Mediacast software, the Mediacast website(s), and the Mediacast e-commerce, chat, hosting, and video/audio streaming and communication systems, you are required to agree to the following "model release and assignment of intellectual property rights";

I agree to be filmed / videotaped and or photographed in connection with Mediacast, Mediacast, subsidiaries, licensees, and assignees may copyright, use and reuse, publish, distribute, edit, excerpt, exhibit and otherwise exploit my name (real or fictional), likeness, persona, performance, voice, pictures, chat, video, audio, biological information and identification, and statements, (collectively my "appearance") for any and all uses, in whole or in part, in any and all media and manners now known or learned, for use throughout the universe, in perpetuity, without limitation, including in connection with the advertising, exploitation and publishing of Mediacast and its affiliates.
